- 1. To increase the Authorized Capital of the company from existing Tk. 50,00,00,000.00 (Taka fifty crore) to Tk. 100,00,00,000.00 (Taka one hundred crore) appearing in Under Section V of the Memorandum of Association and Under Section 5(a) of the Articles of Association of the Company as the Authorized Capital shall be replaced by the amount of Tk. 100,00,00,000.00(Taka one hundred crore).
